## CONDITIONS FOR PARTICIPATION IN MOBELMESSEN 2017

1. You can register online on [www.mobelmessen.dk/register](http://www.mobelmessen.dk/register) or print out, complete, sign and send in registration form via mail. No registration will be confirmed before the registration form is received. Registration is binding and payment of full participation fee is liable when deposit for participation has been paid.  
The organizer reserves the right to distribute stands to all exhibitors. Any requests are to be noted on the registration form.
2. The registration form states what are included in the participation fee. All other matters must be agreed with organizer.
3. The Organizer reserves the right to stop further registration or to limit the booked number of square meters if the fair is fully booked before the deadline of registration. If an exhibitor does not want an allocated space, the organizer reserves the right to allocate a new space or refuse the exhibitor participation. The organizer also reserves the right to refuse registration of certain products and services. The organizer has last decision in any conflict about space allocation.
4. Participation cost is 595 DKK per Square meter. Registration before June 1st 2017 only 550 DKK per Square meter.  
Payment as follows:  
Registration and marketing fee DKK 1900, -. To be paid at registration.  
20 % of participation fee (deposit) will be invoiced for payment latest July 1st 2017. By later registration the deposit must be paid immediately after registration. Remainder of participation fee is due (80%) on October 5th 2017.
5. In case exhibitor does not turn up, cancels his participation or brakes the contract he is liable for the full participation fee. Even if stand that was allocated for the Exhibitor is rented to another exhibitor.
6. The stand must be manned at all times during opening hours.
7. It is not allowed to give rented space to other companies.
8. Posters and other advertising materials cannot be posted/exhibited outside the allocated stand without the consent of the organizer. Samples and advertising materials is only allowed to distribute from the exhibitors own stand.
9. Exhibitor is economical and legally responsible for damages they or their employees, products or the like is inflicting on building or persons. The exhibitor is obliged to follow normal or special conditions and security measures that the organizer deems necessary. Necessary repairs will be made on the exhibitors account. Especially must damages on floor and wall elements be avoided.  
Exhibitor must organize all transport, assembly, packing of own products. All exhibited products and valuable should be marked with exhibitors name.
10. After the fair the stand must be left without waste, decorations or the like. Cost for cleaning or destruction of waste to be invoiced to exhibitor.
11. Halls will be guarded during the whole fair period, but the organizer acknowledges no responsibility for any exhibited goods or personal belongings. Necessary insurance is covered by exhibitor.
12. Built-up period from Monday 6th of November 2017 from 8 to 18 and Tuesday 9th of November 2017 from 8 to 20.
13. Brake down period is Friday 10th of November from 16 to 22. and Monday 13th of November from 8 to 12, at what time the stand must be completely empty. Any dismantling of stand and/or removal of furniture before 16 is prohibited.
14. Even in case the fair due to circumstances outside the control of the organizer, such as force majeure, fire, flooding, strikes, lock outs or the like cannot be held, the exhibitor has no right to any form of compensation from the organizer.
15. It is understood that the exhibitor adhere to all rules, laws and regulations, and get eventually necessary permissions from relevant authorities.
16. Above mentioned is valid whichever reservations have been taken.
17. The organizer reserves the right to use the exhibitors name in connection with marketing and sales activities for møbelmessen 2017.
